Part 1 - General

Sealed bid proposals for <u>Hanover Township Park Restroom</u> will be received by the Hanover Township Administrator, 2595 Old Oxford Road, Hamilton, Ohio 45013, until 12:00pm, local time on April 22, 2024.

Bids shall be delivered in a sealed envelope indicating "Sealed Bid Enclosed", the Bidder's name and address, <u>the name</u> <u>and phone number of the bidder's contact person</u>, and "Hanover Township Park Restroom." The bids shall be noted for date and time upon receipt. All bids shall be reviewed by the Administrator of Hanover Township and Architect on April 23-24, 2024. Bids received after 12:00pm April 22, 2024, will be returned unopened.

The Hanover Township Park Restroom New Construction work will be executed under a single Prime Contract, executed on a lump sum basis. The Work shall include but not limited to:

- 1. New ground up construction of 670 square feet structure, supported on a shallow foundation,
- 2. Clad in Horizontal Aluminum Wood Look Cladding over CMU walls,

3. Site work including, parking at existing restroom being removed in parking lot, stormwater management, new septic/sewer,

- 4. New primary electrical service, including LED lighting, technology, and miscellaneous equipment,
- 5. New plumbing equipment,
- 6. New mechanical equipment,
- 7. Interior CMU finishes,
